



AUM SCHOOL SEASONAL CAMP TERMS AND CONDITIONS

1. As the legal parent or guardian of each child identified on the registration page, I hereby consent to the child's participation in the Aum School seasonal camp ("the Event") conducted by Aum Education Society of America ("Aum School").
2. As the legal parent or guardian of each registered child, I hereby represent and warrant that I have taken reasonable precautions to protect **other persons** attending the Event against exposure to, or the possibility of contracting, **COVID-19**. In particular, I hereby represent and warrant that each registered child will **not** attend the Event if (a) the child has had direct contact, within the fourteen (14) days before the Event, with an individual with a confirmed case of **COVID-19** or (b) the child has any symptom, including but not limited to elevated temperature of 100 or more, cough, difficulty breathing, headache, loss of taste or smell, or muscle pain, on the day of the Event.
3. As the legal parent or guardian of each registered child, I hereby acknowledge that the child's participation in the Event will include participation in athletic activities, such as sports and yogasanas, and that participation in such athletic activities may expose the child to the risk of bodily injury. Accordingly, I hereby further acknowledge that I have given my consent to the child's participation in the Event having **assumed the risk of bodily injury** to the child.
4. As the legal parent or guardian of each registered child, in the event that the child suffers bodily injury while participating in the Event, I hereby authorize Aum School and its employees and volunteers present at the Event to authorize any emergency medical or surgical treatment deemed to be in the best interest of the child if I am unavailable or otherwise unable to do so. I hereby further agree to assume full responsibility for the payment of all fees and expenses incurred for any such emergency medical or surgical treatment so received by the child.
5. As the legal parent or guardian of each registered child, on behalf of myself and the child, I hereby agree to **RELEASE, INDEMNIFY, AND HOLD HARMLESS** Aum School and its directors, officers, employees, representatives, agents, and volunteers ("the Indemnified Parties") from all claims for damages or injunctive relief resulting from the child's participation in the Event, including any claim alleging that damages or injuries were caused by the **NEGLIGENCE** of any of the Indemnified Parties.
6. As the legal parent or guardian of each registered child, on behalf of myself and the child, I hereby consent to the search of the child's personal belongings by Aum School during the Event to ensure the safety of all Event participants.
7. As the legal parent or guardian of each registered child, on behalf of myself and the child, I hereby agree that the child and I shall comply with the policies and procedures established by Aum School for participation in the Event. I hereby acknowledge that, in the event that Aum School determines in its sole discretion that the child or I have failed to comply with these policies

and procedures, Aum School reserves the right to expel the child or me from the Event immediately without refund of any fees paid.

8. As the legal parent or guardian of each registered child, on behalf of myself and the child, I hereby irrevocably authorize, consent, and give Aum School the right to use, publish, and exploit for any and all advertising, marketing, endorsement, commercial, and trade purposes whatsoever (including but not limited to advertising, promoting, or publicizing Aum School and its services) the child's name, likeness, portrait, recorded voice, and image; statements made by the child; and biographical material ("Materials"). As the legal parent or guardian of each registered child, I hereby specifically acknowledge that the Materials are being recorded for, among other things, publication on the Internet, and I consent on behalf of myself and the child to such use.

9. As the legal parent or guardian of each registered child, on behalf of myself and the child, I hereby agree to **RELEASE, INDEMNIFY, AND HOLD HARMLESS** the Indemnified Parties from any and all claims and liability for compensation, damages, or injury, including but not limited to claims for libel, false light, invasion of privacy, or other infringements of personal, property, or proprietary rights of any nature, foreseen or unforeseen, associated with or arising out of the publication or other uses of these Materials regardless of the nature of such use.

10. As the legal parent or guardian of each registered child, on behalf of myself and the child, I hereby waive any right that I or the child might have to inspect or approve the Materials, the use of the Materials, the finished product, and any advertising copy or printed matter. I am aware that any and all recordings and Materials may be edited and juxtaposed with other material, and I hereby consent on behalf of myself and the child to such uses of the Materials.

As the legal parent or guardian of each registered child, I hereby acknowledge that I have read these Terms and Conditions; that I fully understand them; that I have knowingly and voluntarily agreed to them; that I am more than 18 years of age; that I am the parent or legal guardian of the registered child; and that I intend to be legally bound by these Terms and Conditions.

12. As the legal parent or guardian of each registered child, I hereby acknowledge that by agreeing to these Terms and Conditions, I am knowingly and voluntarily waiving certain legal rights on behalf of myself and the child.
